At this stage there is limited information in terms of what the junior rugby season might look like and a potential draw, other than the mention of a possibility of having a later season. Therefore, calculations have been based on the same assumptions made for the 2019 season (other than total junior teams have increased from 9 to 10 teams).			
This funding allows for continued support of our parents and junior rugby club to subsidise travel costs. By supporting our coaches and parents with travel subsidy, our junior membership numbers are forecasted to increase to 10 teams in the 2020 season.
