Hi Selina

Unfortunately, none of the suggested names for the development at 594 Koutu Loop Road are acceptable to be used at this location.

As you identified with Hokianga Rise, there is Hokianga Harbour Drive in the vicinity (approx. 4kms) This also means that the suggested name of Harbour Rise isn't acceptable because of the proximity to Hokianga Harbour Drive.

Point Rise is not acceptable to use as Koutu Point Road in in the immediate vicinity of the new road location. The replication of these names from existing roads in close proximity has the potential to create confusion.
