- Met with Murray Bane to review Far North Holding Limited. The singular message is ensure that the notions that have been discussed here at Te Kuaka are fed back to those CCO.
- Iwi and Hapu are being asked to attend a number of regional conversations.
- Mentioned a deputation to the Transport and Infrastructure Committee regarding the building of a 4 lane highway from Warkworth to Kaikohe.
- Small roopu went to Honolulu and met with whānau from Rapa Nui, Tonga, Samoa, Niue, Tuvalu, Guam, Melanesia and Pilau to take a voyaging narrative beyond the horizon and report back. What that report back looks like is that there are people out there who think like us, look like us, speak like us and have the same pain points as us. The take-away was that they're not as angry as us. They have different reflections on the same kaupapa with the same narratives.
