# Te Kahu o Taonui Report for Te Kuaka – Te Ao Māori Committee. February 2025

#### Introduction

Te Kahu o Taonui was established in 2006/7, as a collective of lwi in Te Taitokerau. Te Kahu o Taonui now includes representation from the following lwi: Ngāti Kuri, Te Aupōuri, Ngāi Takoto, Te Rarawa, Ngāti Kahu, Ngātikahu ki Whangaroa (Kahukuraariki Trust), Whaingaroa, Ngāpuhi, Ngāti Hine, Te Roroa, Ngāti Wai and Ngāti Whātua.

# **Purpose**

#### Te Kahu o Taonui Co-Chair steps down

Tirohia ngā tai e papaki tū ana, Te Tai Tama Tāne,

Te Tai Tama Wahine,

Te Hiku Roa o te Ika a Māui e whiuwhiu ana i ngā tai o Te Tokerau e haruru nei! He mihi tēnei nā ngā iwi o Te Tai Tokerau e hipokina ana ki Te Kahu o Taonui ki tā mātou karanga maha, te hoa Toihau, a Harry Burkhardt, kua heke nei i tana tūranga. Kua roa a Harry e pīkauria ana i ngā manako a ngā iwi huri noa i Te Taitokerau. Kua whakapau kaha ia ki te hautū i te waka o Te Kahu o Taonui, nā ka mihi rā ki a ia, ki tana whānau, otirā ki tana nui o Ngāti Kuri i tuku i a Harry ki te kōkiri i ngā mahi nui whakahirahira kua tutuki nei e ia.

I whakataukitia te kōrero e tāna iwi o Ngāti Kurī e mea ana, "Me he rākau māmore āu nei, tū ake." No reira, hei te rākau māmore o Ngāti Kurī, otirā Te Taitokerau, tēnā koe i ōu whakapaunga werawera.



Te Kahu o Taonui Lead Co-Chair Harry Burkhardt has made the difficult decision to step down from the role. His leadership has been instrumental in advancing the collective aspirations of our lwi, and we acknowledge his dedication and contributions to our kaupapa.

A transition plan is being discussed to ensure continuity and stability. The appointment of a new Co-Chair will be guided by our lwi Heamana at the April hui, where lwi leaders will also determine the partnerships and relationships that align with and uphold the kaupapa of Te Kahu o Taonui.

Te Kahu o Taonui has actively engaged in advocacy by submitting responses to several proposed legislative changes in Aotearoa. These submissions reflect our commitment to protecting the interests of our lwi, upholding Te Tiriti o Waitangi me He Whakaputanga and the aspirations of our Tupuna. Our continued participation in these processes reinforces our role as a collective voice for Te Taitokerau lwi.

# **National Iwi Chairs Forum February 2025**

Te Rarawa hosted 83 lwi from across Aotearoa at the National lwi Chairs Forum 2<sup>nd</sup>-4<sup>th</sup> Pēpuere, at the Waitangi Treaty Grounds.

Taitokerau iwi united on matters impacting our rohe. It was collectively decided that the following issues are top priorities for our region, a follow up strategic hui will take place April 15 for collective solutions to the priority areas:

- Pou Tangata Housing, Hauora, Mātauranga/Education Whanau Prosperity
- Pou Tāhua Economic Infrastructure, Energy, Aquaculture
- Pou Taiao Mana o te Wai, Kai Sovereignty
- Pou Tikanga constitutional transformation, relationships

Te Kahu o Taonui collective will be hosting the National Iwi Chairs Forum in February 2026.



### **Taiao Portal Update**

The Taiao Portal project has three major workstreams:

- A resource consents portal
- Taiao capability development including GIS; and
- Toitū te Taiao for information sharing and engagement.

This update focuses on the resource consents (RC) portal.

#### **Background**


Funding was secured from the Department of Internal Affairs (DIA), through the FNDC to develop a Taiao Portal to enable:

- Better visibility of real time (and historic) RC information for iwi and hapū; and
- To provide RC data in a timely manner so that iwi and hapū can respond to applications within the statutory timeframe.

The ability of iwi Māori to respond effectively has been hampered by a range of factors<sup>1</sup> specifically the time constraints around receiving and being able to adequately respond to RC applications.

The portal is designed to enable RC information from FNDC to be relayed quickly out to our iwi authorities, determined by the distribution channels preferred by each iwi and the portal will also include templates to enable a more rapid response.

We are working with Takiwā (<a href="https://takiwa.co/">https://takiwa.co/</a>) to develop and enhance the IT backbone for the portal.



Te Kahu o Taonui Taiao Portal Data Flow Diagram


Working with FNDC systems and processes to achieve more effective RC information exchange has been challenging timewise, given that they are currently undergoing an IT infrastructure change.



We are currently looking at the FNDC login mechanism and are in the process of confirming what, if any, changes should be made to access FNDC data. It would be ideal if we could pull FNDCs RC data along with the .pdf link/file but are yet to confirm if this is possible with the current systems that we are working with.


Pilot trials will begin as soon as we are able to manage the PDF files with the integration of GIS data.

Similarly, and as part of their Tāiki ē commitments, NRC is reviewing their RC processes, and we are currently engaging with them with the intention that the RC portal will be replicated to provide iwi with both regional and district council RC applications.



Tāiki ē – Resource Consent Review: 11 Recommendations






Tāiki ē – Resource Consent Review: Key Synergy
