#### The Local Government Act 2002 states the role of a Community Board is to:

- A. Represent, and act as an advocate for, the interests of its community.
- B. Consider and report on all matters referred to it by the territorial authority, or any matter of interest or concern to the community board.
- C. Maintain an overview of services provided by the territorial authority within the community.
- D. Prepare an annual submission to the territorial authority for expenditure within the community.
- E. Communicate with community organisations and special interest groups within the community.
- F. Undertake any other responsibilities that are delegated to it by the territorial authority

#### Council Delegations to Community Boards - January 2013

The "civic amenities" referred to in these delegations include the following Council activities:

- Amenity lighting
- Cemeteries
- Drainage (does not include reticulated stormwater systems)
- Footpaths/cycle ways and walkways.
- Public toilets
- Reserves
- Halls
- Swimming pools
- Town litter
- Town beautification and maintenance
- Street furniture including public information signage.
- Street/public Art.
- Trees on Council land
- Off road public car parks.
- Lindvart Park a Kaikohe-Hokianga Community Board civic amenity.

**Exclusions:** From time to time Council may consider some activities and assets as having district wide significance and these will remain the responsibility of Council. These currently include: The roading network, Hundertwasser toilets, District Library Network, Baysport, the Kerikeri, Kaikohe & Kaitaia Airports, Hokianga Vehicle Ferry, i-Site network, Far North Community Centre, Kerikeri Domain, Kawakawa Heated Swimming Pool, Kaikohe Cemetery, Kerikeri Sports Complex, The Centre at Kerikeri, the Bay of Islands/Hokianga Cycle Trail.

Set local priorities for minor capital works in accordance with existing strategies,

- 1. Recommend local service levels and asset development priorities for civic amenities as part of the Annual Plan and Long Term Plan processes.
- 2. Reallocate capital budgets within the Annual Plan of up to 5% for any specific civic amenity, provided that the overall activity budgetary targets are met.
- 3. Make grants from the allocated Community Funds in accordance with policy 3209, and the SPARC/Sport Northland Rural Travel fund in accordance with the criteria set by the respective body, and, for the Bay of Islands-Whangaroa Community Board, the power to allocate the Hundertwasser Donations Account.
- 4. Provide comment to council staff on resource consent applications having significance within the Community, including the provision of land for reserves or other public purposes.
- 5. To hold, or participate in hearings, as the Council considers appropriate, in relation to submissions pertinent to their community made to plans and strategies including the Long Term Plan and Annual Plan, and if appropriate recommend decisions to the Council.

- 6. To hold hearings of submissions received as a result of Special Consultative Procedures carried out in respect of any matter other than an Annual or Long Term Plan and make recommendations to the Council.
- 7. Where recommended by staff to appoint management committees for local reserves, cemeteries, halls, and community centres.
- 8. To allocate names for previously unnamed local roads, reserves and other community facilities, and recommend to Council name changes of previously named roads, reserves, and community facilities subject to consultation with the community.
- 9. To consider the provisions of new and reviewed reserve management plans for recommendation to the Council in accordance with the Reserves Act 1977 and hear or participate in the hearing of submissions thereto, as considered appropriate by the Council.
- 10. To provide recommendations to the Council in respect of applications for the use and/or lease of reserves not contemplated by an existing reserve management plan.
- 11. Prohibit the use of skateboards in specified locations within their communities, in accordance with Council's Skating Bylaw 1998.
- 12. Recommend new bylaws or amendments to existing bylaws.
- 13. Prepare and review management plans for local cemeteries within budget parameters and in a manner consistent with Council Policy.
- 14. Exercise the following powers in respect of the Council bylaws within their community:
  - a) Control of Use of Public Spaces Dispensations on signs
  - b) Mobile Shops and Hawkers Recommend places where mobile shops and/or hawkers should not be permitted.
  - c) Parking and Traffic Control Recommend parking restrictions, and areas where complying camping vehicles may park, and consider and grant dispensations in accordance with clause 2007.2
  - d) Public Places Liquor Control Recommend times and places where the possession or drinking of alcohol should be prohibited.
  - e) Speed Limits Recommend places and speed limits which should be imposed.
- 15. To appoint Community Board members to speak on behalf of their community in respect of submissions or petitions.
- 16. Specific to the Bay of Islands-Whangaroa Community Board consider any recommendations of the Paihia Heritage Working Group and make appropriate recommendations to Council on the development of a draft Plan Change and a Section 32 analysis on heritage provisions for Paihia.
- 17. To set schedule of meeting dates, times and venues, subject to the meetings not conflicting with meetings of the Council and satisfying the provisions of the Local Government Official information and Meetings Act 1987.
- 18. To review all proposed public art projects on a project-by project basis to ensure they comply with policy #5105 Art in Public Places, including approval of the aesthetic appearance, maintenance programme, insurance and appropriate location, and to agree to their installation.
- 19. In respect of applications from food establishments for permission to establish tables and chairs on a public place, i.e. Alfresco dining in accordance with Policy 3116, to consider and decide on any application which does not meet all criteria of the policy, and any application which staff recommend to be declined.

20. Subject to a report from the appropriate managers and the appropriate budgetary provision, to make decisions in respect of civic amenities including the levels of service, and the provision or removal of an amenity not provided for elsewhere in these delegations.

#### **Terms of Reference**

In fulfilling its role and giving effect to its delegations, Community Boards are expected to:

- 1. Comment on adverse performance to the Chief Executive in respect of service delivery.
- 2. Assist their communities in the development of structure plans, emergency management community response plans, and community development plans.
- 3. Assist their communities to set priorities for Pride of Place programmes.
- 4. Have special regard for the views of Māori.
- 5. Have special regard for the views of special interest groups, e.g. disabled, youth, aged, etc.
- 6. Actively participate in community consultation and advocacy and keep Council informed on local issues.
- 7. Seek and report to Council community feedback on current issues by:
  - a) Holding a Community forum prior to Board meetings
  - b) Varying the venues of Board meetings to enable access by members of the community
- 8. Monitor and make recommendations to Council to improve effectiveness of policy.
- 9. Appoint a member to receive Annual Plan\Long Term Council Community Plan submissions pertinent to the Board area, attend hearings within the Board area, and attend Council deliberations prior to the Plan adoption.

#### **Protocols**

In supporting Community Boards to fulfil their role, the Council will:

- 1. Provide appropriate management support for the Boards.
- 2. Organise and host regular workshops with the Community Boards I to assess the 'State of the Wards & District' to establish spending priorities.
- 3. Prior to decision-making, seek and include 'Community Board views' in Council reports in relation to:
  - a) the disposal and purchase of land
  - b) proposals to acquire or dispose of reserves
  - c) representation reviews
  - d) development of new maritime facilities
  - e) community development plans and structure plans
  - f) removal and protection of trees
  - g) local economic development initiatives
  - h) changes to the Resource Management Plan
- 4. Organise and host quarterly meetings between Boards, the CEO and senior management staff.
- 5. Prepare an induction/familiarisation process targeting new members in particular early in the term.
- 6. Support Board members to arrange meetings with local agencies and service clubs to place more emphasis on partnerships and raising profile of the Boards as community leaders.
- 7. Permit Board chairperson (or nominated member) speaking rights at Council meetings.
- 8. Help Boards to implement local community projects.
- 9. Arrange for Infrastructure and Asset Management Staff to meet with the Community Boards in September each year to agree the capital works for the forthcoming year for input into the Annual or Long Term Plan.
- 10. Provide information.

#### TAKE PŪRONGO / PURPOSE OF THE REPORT

To seek the Bay of Islands Community Board recommendation to Council to initiate public consultation on the granting of a new ground lease over part lot 37 Te Kemara Avenue, Waitangi, being recreation reserve under Section 54 Reserves Act 1977, to TriOceans Limited

#### WHAKARĀPOPOTO MATUA / EXECUTIVE SUMMARY

- TriOceans Limited seek to give the Tui at Waitangi a new lease of life through alterations which will promote a marine exhibition space, classroom, café and toilets.
- TriOceans Limited own the boat and have a resource consent with Northland Regional Council for the placement of the boat within the water.
- They are requesting a ground lease over the reserve directly in front of the boat to place a ramp for accessibility and to provide carparks to the facility.
- The Reserves Act 1977 requires public consultation on the issuing of a ground over a Recreation Reserve when no Reserve Management Plan is in place.

#### TŪTOHUNGA / RECOMMENDATION

That the Bay of Islands - Whangaroa Community Board recommend to Council:

- a) that the public consultation process is commenced on the granting of a new ground lease to TriOceans Limited over part lot 37 Te Kemara, Avenue, Paihia, Recreation Reserve being approximately 706.9 square metres, held in New Zealand Gazette 1980 page 2049.
- b) The terms of the proposed lease shall be:
- Term: 30 Years (10+10+10)
- Annual Rental: \$121 plus GST for 2024/25 and reviewed annually in conjunction with the FNDC Fees and Charges Schedule; and
- c) That the Bay of Islands Whangaroa Community Board is appointed to hear any submissions received in response to the consultation process and to make recommendations to Council.

#### 1) TĀHUHU KŌRERO / BACKGROUND

#### **TriOceans Ltd & The TriOceans Education Trust**

**TriOceans Ltd** (The Tangaroa Research Institute of Oceanographic Studies) is a collective of scientists and innovators with a strong academic foundation in marine mammal science and marine education. Their mission is to conduct high-quality research, inspire conservation through education, and integrate Mātauranga Māori with modern scientific techniques. Established in 2015 in the Bay of Islands, they have been dedicated to enhancing their understanding of the marine environment and fostering its protection.

In 2023, recognizing the need to formalize and expand their charitable work, they established the **TriOceans Education Trust**. The Trust is governed by a highly skilled and passionate board, consisting of Hapū representatives, educators, and scientists. The Trust's core objectives are:

"To inspire and educate the people and communities of New Zealand on the importance of Aotearoa's marine environment, empowering all ages to connect deeply with te moana and support its conservation through kaitiakitanga. This is achieved by interweaving significant scientific research, Mātauranga Māori, and hands-on educational programs."

Through both TriOceans Ltd and the Trust, they have delivered significant marine research, custom education programs such as the Marine Kaitiaki Program, and the ESTEM Global Awards Program for Northland schools. Their work has brought about real, positive changes for the Northland marine environment, impacting both local communities and broader conservation efforts.

#### The Tui: A New Vision for Marine Education

As part of their ongoing efforts to connect people with the marine environment, TriOceans Ltd has acquired the Tui—an iconic local structure—which will be run by the TriOceans Education Trust. They propose transforming the Tui into a multi-functional marine education facility that is accessible and free to the community. This innovative space will feature three key areas:

- An Education Centre: A space for interactive learning about marine ecosystems, conservation, and Mātauranga Māori.
- A Dedicated Classroom: A venue for tailored educational programs, workshops, and activities.
- A Community Gathering Space/Café: A welcoming space for the community to meet, discuss marine issues, and enjoy a cup of coffee, while promoting informal learning and engagement.

Historically, the people of Northland have had a deep and lasting connection to the marine environment, living by and from the sea. However, opportunities for many to fully understand and engage with the changing dynamics of marine ecosystems and their connection to Mātauranga Māori have been limited. The need for a community space that celebrates this identity and empowers people to protect and conserve the local marine environment has never been more pressing.

By revitalizing the Tui in this way, they aim to provide the people of Northland with a place to connect, learn, and engage with the marine environment in a meaningful way. They are committed to ensuring that this facility is inclusive, accessible, and effective in promoting community-driven marine conservation.


TrioOeans Limited are now requesting a ground lease of part of the reserve area located directly in front of the Tui. The area would be used to provide accessible parking and ramps, ensuring that the facility is wheelchair accessible for the first time. This will enable all members of the community to participate in their programs, regardless of physical ability. They do not intend to run day-to-day activities on the reserve.

For clarity, TriOceans Limited are the legal owners of the Tui and are responsible for compliance, maintenance and overall running of the property. TriOceans Educational Trust lease part of the ship from TriOceans Limited to provide the public education work.

#### 2) MATAPAKI ME NGĀ KŌWHIRINGA / DISCUSSION AND OPTIONS

TriOceans Limited have requested a lease over the entire reserve to safeguard and manage the area consistently. However, part of this reserve is utilised for Waitangi week celebrations, and providing a lease over the whole section would reduce the area permitted for these celebrations.

TriOceans Limited own the boat, and TriOceans Educational Trust hold a 100 year lease of the building and will be the group running it. Funding to undertake repairs is being sought through the Trust.

Resource Consent was granted to construct access ramps and landing areas on 17 February 2025.

Engagement with iwi and hapū has been carried out by TriOceans Limited as part of their Northland Regional Council draft consent application. Whilst there is clear support for this project, Far North District Council is required to carry out public consultation as part of the granting of a lease over recreation reserves, as per the Reserves Act 1977.

#### **Delegation to Council**

The 2013 Minister of Conservation Reserves Act Delegations provide for Local Authorities to wear the hat of the Minister for delegated actions over vested recreation reserves.

Section 54(1) of the Reserves Act 1977 ("the Act") provides for Council, with the prior consent of the Minister, to grant leases over recreation reserves. From 2013, prior consent of the Minister is delegated to Council.

Section 54(2) Reserves Act 1977 requires public notification of the proposed lease action where no current reserve management plan is in place for the vested recreation reserve.

Council resolution to commence public consultation satisfies the prior consent of the Minister and the public notice requirements.

#### Council delegations: the role of the Board vs the role of the Council

Community Boards are delegated to provide recommendations to Council in respect to applications for the use and/or lease of reserves not contemplated by an existing reserve management plan.

The Bay of Islands - Whangaroa Community Board is therefore now required to make a recommendation to Council in respect of the proposal.

#### The options for this site are:

#### **Option 1: Recommended**

That the Bay of Islands - Whangaroa Community Board recommend to Council:

- a) that the public consultation process is commenced on the granting of a new ground lease to Trioceans Limited over part lot 37 Te Kemara, Avenue, Paihia, Recreation Reserve being approximately 706.9 square metres, held in New Zealand Gazette 1980 page 2049.
- b) The terms of the proposed lease shall be:
  - Term: 30 Years (10+10+10)
  - Annual Rental: \$121 plus GST for 2024/25 and reviewed annually in conjunction with the FNDC Fees and Charges Schedule; and
- c) That the Bay of Islands Whangaroa Community Board is appointed to hear any submissions received in response to the consultation process and to make recommendations to Council.

Option 1 is for part of the reserve, allowing the TriOceans Limited to establish access to the Tui, ensuring that the facility is wheelchair accessible for the first time. This will enable all members of

the community to participate in their programs, regardless of physical ability. They do not intend to run day-to-day activities on the reserve.

#### Option 2:

That the Bay of Islands - Whangaroa Community Board recommend to Council:

- d) that the public consultation process is commenced on the granting of a new ground lease to Trioceans Limited over lot 37 Te Kemara, Avenue, Paihia, Recreation Reserve being approximately 2044.57 square metres, held in New Zealand Gazette 1980 page 2049.
- e) The terms of the proposed lease shall be:
  - Term: 30 Years (10+10+10)
  - Annual Rental: \$121 plus GST for 2024/25 and reviewed annually in conjunction with the FNDC Fees and Charges Schedule; and
- f) That the Bay of Islands Whangaroa Community Board is appointed to hear any submissions received in response to the consultation process and to make recommendations to Council.

This option allows for a lease over the entire reserve as requested initially by TriOceans Limited. This option is not recommended as it reduces the area of land available for members of the public during Waitangi week.

#### Option 3:

- a. Decline TriOceans Limited request for a new ground lease.
- b. Advise TriOceans Limited to find other ways to access the Tui.

#### TAKE TUTOHUNGA / REASON FOR THE RECOMMENDATION

The only way to access the Tui is through the Far North District Council recreation reserve land. Relocation of the boat is not an option. There is clear support from iwi and hapū that has been presented as part of the Northland Regional Council consent application.

As per the Reserves Act 1977, Council can grant exclusive leases to part or all of a reserve for a maximum term of 30 years.

Public Notice is a statutory requirement under Reserves Act for the leasing of a Recreation Reserve.

Public consultation will enable the Bay of Islands Community Board and Council to assess the community's engagement with TriOceans Limited proposal. Public consultation gives the community the opportunity to put forward alternative options for the use of the site.

## 3) PĀNGA PŪTEA ME NGĀ WĀHANGA TAHUA / FINANCIAL IMPLICATIONS AND BUDGETARY PROVISION

TriOceans Education Trust is a registered charity (CC62277) and will be running the boat/building. It is intended to provide a community benefit and not a commercial venture.

The lease will provide for the lessee to be responsible for all ongoing maintenance of the associated green space.

All improvements will be owned by TrOceans Limited.

The annual rent will be in conjunction with Far North District Council Fees and Charges Schedule and amended annually.

From lane Ayr BOI Community Board Kerikeri SB

I was recently approached by Mr Bob Bingham from "Kerikeriwalks" Bob is a long time community volunteer one of many that create, maintain and promote local walking tracks. As you will appreciate it is our community volunteers that provide those services that enhance the community and would be unaffordable from Council resources.

Bob and his group have several walking tracts through the BING Property that has recently sold and in the process of being developed. He has been in contact with the Developer who has indicated that he plans several "reserves" within the property.

It is presumed by most parties that there will be space for a "track" along the river, public access to the river was noted in several submission.

Concern is raised that if there are other reserves formed that they, if possible, should be able to be connected to the river track, connectivity is of great importance.

When developers trade reserve space for some concession there should be benefit to the entire Community I would point out the fenced tennis court that is in fact a reserve created at Alderton Park in Kerikeri. There is no benefit to the Community yet the ratepayers are expected to repair.

Inc., was set up with a committee consisting of Messrs E.S. Answorth, J.R. Lyness, A.M.V. Greig, T.B. Swann, F. Butler, S. Bates and E. Cooper. Six acres were purchased from the Corporation and a group, Recreation eserve Inc., was founded with a subscription of five shillings per annum. By 1936 the purchase was complete and a small pavilion had been built. Syd Jolly subsequently made a gift of another 3 acres. During the 1930s the drive for instrict amenities continued to be spearheaded by the Settlers Association, with between fifty and sixty members at meetings. Captain Voelcker resigned the mairmanship after five years. A. Tomlinson was chairman for two years during which time a rural delivery service was inaugurated with the acceptance of the lander of C.O. Tubbs. Prior to this, mail was delivered by the storekeepers in their delivery vans. An aerodrome site was decided on. Such matters as roading, and taxi service and afforestation of Crown lands were constantly on the agenda.

Through pressure from the Settlers Association and from Councillor H.T. Bates, relief workers were employed on Bulls Road and, by 1936, it had been reformed and metalled. In the same year a bridge was built as access to a road down the Kerikeri Inlet, to link up with Paihia. It was, in hope, named Waitangi Road. Springbank Road was also re-formed.

Reginald Waters became chairman of the Association in 1938, with H.M. Alexander taking over the position of secretary. Only a matter of months later, Waters fell from his horse and died. He had served as secretary-treasurer from the inception of the Alderton Group Settlers' Association in 1929 and in the same capacity in the Kerikeri Settlers' Association from 1931. He had given devoted service to the community, assuming in his executive position much of the responsibility for establishing the horticultural concept, and his administrative expertise had contributed to the founding of what was virtually a new municipal district. His death was a great shock and loss to the whole community. With donations stone gateposts were erected to his memory at the entrance to the Domain. At a ceremony on 25 April 1940, a plaque was unveiled by Dr James Greig.

Alex Knowles served as chairman of the Association for the following three years, 1938-41. The community was again saddened when Alex died at an early age, leaving his widow, Sis, and young daughter, Mary.

Others who took executive positions in the Settlers' Association were J.A. Cresswell, E.P. Moir, A.H. Pickmere, M.E. Marples, G.G. Thorpe, T.B. Swann, J. McManaway, J.B. Gaisford, D. McGregor-Macdonald, G. Drake and J. Kendall. H.T.Bates was a zealous, consistent advocate and long-term worker for the community. The Association had been very much a male preserve, with women invited only when catering was required. However, on 15 May 1935, it was graciously resolved "That lady members of the family of a commercial member be allowed to attend meetings."

With citrus coming into production, under the auspices of the Kerikeri Settlers Association, a meeting of growers was called in October 1934 to discuss some form of co-operative scheme for the grading, curing, packing and marketing of the fruit. At a meeting at the end of January 1935, growers agreed to support the proposed society. A provisional committee went ahead with plans for the building and equipping of a citrus curing and packing shed. After several visits to Wellington by A.R. Emanuel, and many meetings with Government officials, the Society was able to negotiate a loan of £7,000 with a grant of £500 contingent upon each grower raising a like sum. The number of growers subscribing to the scheme had increased to fifty, representing 24,445 trees. The growers agreed to support the scheme with a levy of 6d per planted tree and 3d per packed case of



Erosion on Rusell Waterfront by Cannon and Butterfish #1, 2,5	The recent storm has now removed additional chunks of the bank in the high risk areas, including an area of high archaeological importance. Regional Council have been assisting but FNDC is not acting with any sense of urgency to this major issue.
Memorial Street for Janet Planet #3	The family are still waiting to hear back from Council on this. Please advise if someone has spoken with them.
Ongoing delays in Duffus Trust Building Consent #3	There seems to be a blockage which cannot be resolved by Council or the Trust, holding up proceedings.
Parking in Russell over summer #3,4	First discussions had. Hope to come with a plan.

Coping with the influx of visitors. #1,3,4	There are a number of infrastructure issues which are inevitable when a community of 750 people increases to 5,000 for a 3-week period. These include parking, litter, water and toilets. Overlay cruise ship visitors on top of this things start to break. This is at a time that Council is shut down so there is limited capacity to deal with issues. I would like to see a more co-ordinated approach to planning so that we are better able to support our communities to provide a great visitor experience at an affordable level for ratepayers.
Russell Urupā (Cemetery) #1, 3, 5	I have now received a reply updating the status of the project. Apparently there was a delay in Stage 1 which took several months to resolve. I have been advised that this is now unblocked, and the project can continue.
Rawhiti Road #1, 2	On 6 March, 2 vehicles collided on Rawhiti Rd. The road has just been recently graded and more metal added to build up the base. Within 2 weeks tyre grooving and judder bars are a hazard and scoria build up particularly on the bends cars can get into slides and this is what happened in this incident. The NTA revaluated this road in June 2022 and the ranking has increased due to the fact that the amenities, including two Marae are at the end of the unsealed section. Member Pihema has now experienced this road and is shocked at its condition.
Home Guard Global Occupation of Tapeka Reserve. <b>#1,3,4,5</b>	With the change of Council staff, it's important to ensure that this is progressed with Police to prevent a repeat of last year's occupation in October. An update is required on progress.
Sewage smells in Matauwhi Bay <b>#1, 5</b>	Hasn't been too bad this summer. Would be interested to understand what if anything has changed.
Sewage smells in Cass Street.	This have been occurring over the past 2 years and have not been dealt with. Multiple RFSs have been raised, and closed with claims that it is seawater in the pipes causing the issue. This has been relatively stable over summer.

#### Other issues

The Placemaking project continues to be stressful with the Public Seating project unable to make any real progress trying to install additional seating on the waterfront. Having scaled back their aspirations significantly, they are still being asked to jump through hoops.
