TE TAKE PŪRONGO / PURPOSE OF THE REPORT

For the Committee to consider a number of key issues related to progressing the Kaikohe Civic Hub project.

TE WHAKARĀPOPOTO MATUA / EXECUTIVE SUMMARY

- Council directed the Chief Executive Officer to re-evaluate the civic and library provisions
 in Kaikohe, including options for the development of a new library, customer service
 centre, assess the options for existing sites, consider other land use options and consider
 the integration of public realm and master-planning of the township into the options.
- A decision report was prepared for the Council Agenda 10 December 2020.
- Council left the report to lie on the table and requested that a steering group be formed and with the Chief Executive work on developing a Terms of Reference
- Because of the scope of the original report (the integration of public realm and masterplanning of the township), it was thought that there be some community presence and that a working party would be an appropriate mechanism to progress the Civic Hub.
- This report seeks the Strategy and Policy Committee endorsement for this change and the proposed Terms of Reference (attached to the report).

NGĀ TŪTOHUNGA / RECOMMENDATION

That the Strategy and Policy Committee:

- a) agree the formation of a Kaikohe Civic Hub Working Party
- b) agree the membership of the Kaikohe Civic Hub Working Party
- c) agree the Terms of Reference for the Kaikohe Civic Hub Working Party

1) TE TĀHUHU KŌRERO / BACKGROUND

With the withdrawal of the Provincial Growth Fund (PGF) \$19.8 million funding for Te Pū o Te Wheke (TPOTW) and certainty from Ngāpuhi Asset Holding Company (NAHC) that the Community Hub will not proceed, Council considered a number of options, at its meeting 10 December 2020, to progress a Civic Hub build (inclusive of a library). These ranged from a standalone library on the Petersen Site through to further land purchases and building a full Civic Hub (total funding \$13,525,000) including a library (610m² with maximum budget of \$4,575,000).

After much discussion, Council resolved to let the report lie on the table and form a Steering Group.

2) TE MATAPAKI ME NGĀ KŌWHIRINGA / DISCUSSION AND OPTIONS

At its meeting, 10 December 2020, Council requested that a Steering Group be formed and that a Terms of Reference be developed:

Moved: Cr John Vujcich Seconded: Cr Moko Tepania

That Council leave the Kaikohe Library and Civic Hub report to lie on the table until the next Council meeting 25 February 2021, and that;

- a) a steering group comprised of: Cr Moko Tepania, Cr David Clendon, Cr Rachel Smith, Cr Kelly Stratford, Cr John Vujcich, and Kaikohe-Holkianga Community Board Chair Mike Edmonds, and that;
- b) the steering group will work on a Terms of Reference with the Chief Executive.

While a Steering Group comprised solely of Elected Members was the resolution, staff would like Elected Members to consider a wider Working Group as a way forward. This consideration was prompted by the content of the report to Council on 10 December 2020, and the ongoing discussion about Mainstreet development, wider community interests, involvement of Akau and some continuity (knowledge) by Members of the Te Pu o Te Wheke Working Group (Councillor Tepania was the Chair along with Mike Shaw, representing community).

Consequently, based on the above, a Terms of Reference has been prepared that includes a proposed wider membership for Council to consider.

Option 1

Endorse the proposal for a Kaikohe Civic Hub Working Party and the Terms of Reference. The group can start work immediately on evaluating options, working with staff to develop a scope in preparation for Council support and resolution to proceed.

Option 2

Set a date for the Steering Group to meet and develop a new Terms of Reference or amend the attached Working Party Terms of Reference.

Staff recommend Option 1.

Te Take Tūtohunga / Reason for the recommendation

To form a Working Party for the funded Civic Hub proposal (including library) to advance the project to fully scoped options in preparation for a Council decision making report.

Te Hōtaka Take Ōkawa / Compliance schedule:

Full consideration has been given to the provisions of the Local Government Act 2002 S77 in relation to decision making, in particular:

- 1. A Local authority must, in the course of the decision-making process,
 - Seek to identify all reasonably practicable options for the achievement of the objective of a decision; and
 - b) Assess the options in terms of their advantages and disadvantages; and

DRAFT Kaikohe Civic Hub Working Party (KCWHP)

Terms of Reference

1. Constitution

The Kaikohe Civic Hub Working Party is established as a Governance working party to provide oversight, engagement, advice and recommendations to the Far North District Council for the development of a Civic Hub in Kaikohe.

2. Purpose of the Working Group

To work in a collaborative manner with the community, in review of options for building a civic hub in Kaikohe and supporting Council to deliver the project operationally.

3. Phase One

The purpose of Phase One of the project is to consider the building of a new Library for Kaikohe, with potential for that infrastructure to be integral to a larger overall community facility.

4. Objectives of the Working Party:

- Engage at a Governance level with lwi, agencies and with community groups
- o Consider site options
- Consult with stakeholders on the size and scope of a Civic Hub appropriate to central Kaikohe
- o Consider the involvement of locals in design and build
- In any recommendations, consider the future-proofing of any infrastructure in terms of financial sustainability over the potential 30 to 50-year lifecycle

5. Membership

The membership of KCHWP shall be comprised of the following:

 A total of at least four Elected Members with voting rights, plus the CEO or his delegate(s) without voting rights

6. Meetings

Meetings shall be held every eight weeks with additional meetings as required, at the discretion of the Chair.

- Meetings shall be chaired by Cr Moko Tepania who will be responsible for setting agendas and running Working Party meetings
- A quorum of members of KCHWP shall consist of three Elected Members
- At these meetings KCHWP may invite staff from the Far North District Council or other organisations as necessary to provide appropriate information
- Meeting decisions have the status of recommendations to Council (Ordinary Council or Committees as appropriate), or to the CEO for lower order issues

7. Engagement protocols

Members of the Working Group will work together in good faith and demonstrate the values of Manaakitanga, Professionalism and Integrity. They will also follow the Communication Guidelines for Elected Members, Chief Executive and staff.

8. Staff support

Subject matter expertise shall be provided by relevant staff members from within the Far North District Council, with enough notice and the approval of CEO and the corresponding General Manager.

9. Administration

Support for administration, including the agenda and meeting minutes, will be provided by Strategic Plans and Policy Group, until such time that the project migrates to a resource consent and construction phases (transfer to District Services Group).

10. Changes to the Terms of Reference

The Working Party may alter the terms of reference when supported through voting by a majority of the membership, for approval by Council. The existence of the body and the fitness of these terms of reference is to be reviewed by 30 June 2021.

11. Resourcing for the Kaikohe Civic Hub

- o Funding the Kaikohe Civic Hub is through the 2021-31 Long Term Plan
- Any requests for resources (eg expenditure for external capability/capacity to inform KCHWP) will be considered by the CEO following normal internal processes
