To provide the Kaitaia Drainage Area Committee with a programme of works for financial years 2024-2027.

WHAKARĀPOPOTO MATUA / EXECUTIVE SUMMARY

- The Kaitaia Land Drainage area has recently been sprayed.
- The Te Hiku Ward Drainage District Control Spraying tender is currently advertised with a closing date of 11th March 2024.
- Council intends to set a programme of works for the next three years to mitigate historical delays with the annual spraying programme.
- The tender award of this work will inform budgets for FY24-27.

TŪTOHUNGA / RECOMMENDATION

That the Kaitaia Drainage Area Committee receive the report Kaitaia Drainage Area Programme 2024-2027.

TĀHUHU KŌRERO / BACKGROUND

The founding of the Kaitaia Drainage Area dates back to 1913 where the Kaitaia Land Drainage Act was adopted with the exception that a committee was to be applied.

The Kaitaia Drainage Area Committee was re-established at the 14 March 2023 meeting of Te Hiku Community Board as part of Council's formal process and procedures.

The delivery of the 2022/2023 work programme was not carried out in accordance with the resolution of the 14 March 2023.

Drain Spraying

The drain lengths to be sprayed have not changed from the 2022/2023 financial years so the spray programme is unchanged including the "On Request" drains.

Spraying of the Kaitaia Drainage Area has since been completed.
