### **Community Issues**

Issue name	Comment
Kaumatua and Kuia Housing deemed unsafe	The safety of the Kaumatua and Kuia housing is a concern because their cars are being broken into. They want more lighting around the outside of flats and around parking. There is also a concern with the current fencing.
Road Safety	Speed of bikes and cars going up the main road and down streets is a concern. There is a notion for speed bumps to be added to our main street of Kaikohe. Pedestrian crossings are also unsafe.
ССТV	With recent break ins of cars and crime on the streets. There is an understanding that there are blind spots. There needs to be more coverage of CCTV.
Civic Plan	Kaikohe Business Association want to put a civil plan together for town beautification.
Signage across the district	Moss and dirt on a large number of road signage across the community. What cyclical maintenance planning is in place to address this?
Public Toilet access area on main street of Kaikohe	Dirty, youth hang out area, gardens and pathway needing serious attention Does not have great signage, hard for visitors to find.
Lindvart Park	Gardens, roadside curbs, and car parks are not well maintained. There needs to be a maintenance plan put in place.
Housing crisis	Many overcrowded dwellings, families living in sub-standard conditions. Is there any support FNDC can offer?
Wastewater discharge into the Hokianga Harbour	Te Mauri o te Wai Inc. shared their historical struggle to get any progress around their aspiration to ensure that no human waste continues to be pumped into the Hokianga Harbour. The group have researched a solution,

funding is available however they were told to wait for a trial to occur as there may be risk involved. They do not want to wait any longer and are seeking urgent support from FNDC to progress this work.

#### **Requests for Service (RFS)**

We have requested a record /report of the past few months Requests for Service so that we have a better understanding of what requests are being made to give us a better view to understanding the areas of concern, where they are coming from and using these to form some opinions around priority areas for Kaikohe/Hokianga Strategic Plan development.

We have been told that the ability to export detailed data about customer issues/themes out of the database by location is unfortunately not something that is built into the functionality of Pathway. A meeting has been diarized to occur in December to offer any Community Board members some liaison

The Business Hub and Events Centre in Kaikohe has recently changed ownership and has been purchased by Karen Hepi. She is also commencing a Bouncy Castle operation.

Te Runanga a iwi o Ngapuhi have recently received \$48 million towards building 665 houses in Kaikohe and Kawakawa.

Kaikohe Christmas Parade is happening on Friday 2nd December, at the time of this report several local businesses, schools and community groups were entered to participate.

The Healing Light Expo was held at Memorial Hall on the 12th and 13th of November and was well attended.
