Kia ora koutou,

As you are aware from my previous emails.

My Whanau and I continue to be concerned in regards to vehicles we witness driving at extremely high speeds.

There has already been a high speed vehicle incident where a car drove into the boat shed out front of the old camping grounds, very, very, Lucky no one was killed. And an accident involving two quads.

It is particularly bad during the holiday season.

We are concerned someone will be hurt or killed.

Since my previous emails I have received an email from Jessie McVeagh (Resident Rawene and volunteer fire fighter Rawene Brigade) see following cut and paste of email and also attended a Opononi Omapere Rate Payers Association (OORA)hui find attached the minutes from the hui held in February.

Jessie McVeagh's email.

I am writing to you all in your capacity as Omapere Opononi Ratepayers Association, as I attended an accident outside the Opononi Four Square today.

One of the main causes of the crash was speed, which resulted in 2 pedestrians being injured badly enough to be flown to Whangarei. This is of course not the first accident or near miss in the vicinity.

Quite a few people from Opononi have approached me over the past few months about traffic calming measures in your area, as I was one of the people who got the speed bumps placed in Rawene. However I feel it is better to come under OORA. (End email from Jessie)

The OORA has raised this matter previously with both FNDC and waka kotahi each claiming no responsibility for decision making in regards to implementing safety actions.

Recently I found the same when addressing the footpaths and berms.

FNDC it's a highway that's waka kotahi, it's an urban area it stays with FNDC. This stretch of road know as state highway 12 and recently Hokianga Harbour Drive and also vehicle GPS TWIN Coast Discovery.

#### Meeting Notes 28/4/22

Present:

Kelvin Davis (MP), Willow Jean Prime (MP), Steve Mutton (Waka Kotahi), Billie (PA to Willow Jean), Shannon Pitman (PA to Kelvin), Hayden Korach (Police road safety director), Rachel Shepherd (Community Constable), Ellen (Community Constable), Moko Tepania (FNDC), Markus Rodgers (Kaumatua), Heather Randerson (community member), Charlotte Taranaki (community member), Craig Joiner (community member) , Wayne Robinson (community member) , Carla Robinson (community member), Suzie Campbell (Chair), Tanya Filia (meeting organizer, community member), Suzanne Duff (note taking, community member).

The meeting opened with a Karakia and welcome led by Markus Rodgers and Moko Tepania.

Suzie Campbell thanked all attendees and organisers, especially Tanya Filia. She stated that though there were many complex issues facing the Hokianga community, the purpose of this meeting was to focus on traffic and road safety.

Tanya Filia outlined grave concerns about recent events, particularly those impacting on her whanau. She stressed that the goal of today is to find common ground and solutions.

Suzie Campbell summarised the issues outlined in the document prepared by Roger Brand including: Signage

Speed and speed limits

State of the footpaths and the need for crossings

Parking (especially boat trailers in high season)

Youth behaviour

Police presence

Communication channels and the frustration of being 'bounced' between Waka Kotahi and FNDC when an issue was identified. We need some clarification regarding accountability.

Steve Mutton addressed many of these issues.

He emphasised that Road Safety is an issue that this government is passionate about and reminded the meeting of the Road to Zero campaign. There is a 3 pronged approach - Safer Drivers, Safer Vehicles, Safer Speeds. Many aspects/interventions planned will have a direct impact upon many of the issues that we are facing in this community. For example:

Safer Drivers – Addressing inequity in access to licenses. A pilot project is currently looking at reducing fees, making second attempt free, and establishing a mobile testing centre. Safer Vehicles – 43% of fatalities occur in 1\* or 2\* safety rated vehicles. We know this as we see the

cars involved. Steve acknowledged that there are lots of challenges in addressing this, but it is seen as a priority.

Safer Speeds – There has been a review of speeds underway since July, and there is a proposal regarding measures to reduce speeds in high risk areas (of which we are one) coming out to the community on May 17<sup>th</sup> for consultation. There will be a 1 month window for feedback. This incorporates some of the suggestions made by OORA in July. It is not a blanket reduction, but instead focuses on 3 main areas – Townships, Schools and Marae. The proposal includes a reduction of the speed limit to 60kms/hr at Pakanae, 40kms/hr in Opononi and establishing a VSL (variable speed limit) around the school. There will also be new signage, and the speed limits will no longer change in summer/winter. The proposal does not include crossings or speed bumps. At the implementation stage, Steve assured us that this area will be prioritised.

He also mentioned that there are 3 more sections of SH 1 that are due for safety upgrades.

Steve also addressed accountabilities on State Highways:

Waka Kotahi is responsible boundary to boundary on open road and kerb to kerb in townships. Anything else is Council.

If there is an abandoned vehicle which is a safety issue, it can be removed immediately.

If it is safely off the road however, legally it cannot be removed for 10 days.

If the car has gone into the Harbour, it is Council's responsibility.

There was further discussion of the youth behaviour issues. Kelvin Davis reminded the meeting of the complexity of the contributing issues and that it takes the whole community to address these. This was widely acknowledged.

Suzie Campbell raised the limitations of funding formulae and the fact that our area repeatedly misses out. Asked the question "What other avenues do we have?" which wasn't really addressed.

Craig Joiner commented on the success of the speed bumps in Rawene for traffic calming. Steve Mutton confirmed that speed bumps cannot be placed on a State Highway. HOWEVER, raised pedestrian crossings CAN be established. One has just gone in in Kawakawa. I think they said that this was under the banner of the Townships Project and had funding from PGF.

Hayden ...... then spoke to the Policing issues.

There has been an increased presence in the last 3 months. This has been noticed. The lack of presence previously was in part due to the competing demands on police time created by COVID, which are now reducing. He has identified this area as a priority area, and will continue to ask his teams to attend regularly. He also asked the community to alert him to upcoming events which may increase the likelihood of risky behaviour, as the police are not always aware. Their focus is particularly on speed, restraints and safety of vehicles.

Suzanne Duff queried whether action should be taken regarding posts on Facebook alerting drivers to speed camera and STOP bus positions. He said that he didn't think that this had much of an impact and that conversely it got the message out that there is a traffic police presence and therefore may be more likely to have a positive impact on behaviour!

Willow Jean Prime stated that now that these issues had been raised, she would endeavour to alert the community or Tania if there were relevant funding opportunities coming up.

The meeting ended with an expression of thanks from Suzie, Tania and Suzanne to all those who attended. Key things expressed:

Important relationship building.

Good to have some clarification of accountabilities.

Good to know what is already underway.

Sense of having been heard and that the issues are being taken seriously.

More hopeful and empowered re possibilities for change.

The meeting was closed by Moko Tepania and we adjourned for a cup of tea and some kai.

Possible Outcomes/Actions:

Await the proposal from Waka Kotahi on May 17<sup>th</sup> and provide feedback, both individual and OORA. Willow Jean will ensure that those who are doing the community consultation and liaison contact Marae. ?Tanya to provide her with relevant contact details.

Pursue the possibility of raised crossings. What would be the possible funding streams and process? Keep liaising with Moko, Steve and Willow Jean about this.
