Community Issues

Issue name	Comment
Wastewater discharge to Hokianga Harbour	Te Mauri o te Wai Inc. are working to have zero human waste to Hokianga waters. The issue is ongoing with 4 WWTP discharging into Hokianga Harbour; Rawene resource consent due for renewal 2023. Opononi Omapere and Kohukohu hearing due soon, Kaikohe has a working group.
Cars left in tide/ on beach	Slow response re removal of car near Pakanae, in part due to FNDC and NRC unclear which organisation is responsible. FNDC is working on developing clear guidelines and processes to ensure quicker response. Car in Pakanae is still in situ due to weather making removal unsafe for contractors to work.

Spraying of roadsides,	Spray-Free Hokianga group requests that FNDC find alternatives to
Rawene	Glyphosate herbicide on roadsides and public areas. FNDC are working on policy and alternative options, with a workshop to be held soon.
Hokianga Community Campus	Concerns from various quarters re the management and future of the Campus.
Litter, waste, recycling services	Litter, illegal dumping, inappropriate burning of waste is a growing problem. South Hokianga request more Council support to address these issues, including clear information on which organisation is responsible for which areas, to provide which service. Desire for signage, education, and support for communities to be informed and empowered in this issue.
Public access to beach Opononi. RFS 4134919 OORRA, Roger Brand	The beach access opposite Opononi Area School; what is the status of public access to the beach from Hokianga Harbour Drive and are there any plans in place to establish a walkway, as described in the Resource Consent 2220314?
Traffic calming, Rwn	Concern that temporary speed bumps are again coming off in Rawene. Where can people find information on when permanent traffic calming will be in place and in which sites?
Footpaths Rawene	Need updates on what, where and when. Publicised timetables are requested.
Rawene Ferry traffic	Concern that the current traffic at Rwn Ferry terminal is unsafe.
Fire Hydrants	Maintenance not sufficient, urgent maintenance required for safety concerns. Which organisation has the responsibility for hydrants, cat's eyes, painting, and maintenance in Rawene and Omapere Opononi? Several RFS's placed.
Erosion Clendon Esp. Rwn	Erosion undermining roadside near boat ramp. OORRA would like Historic ballast stones should be retained in the repair. Several RFS put in by public.
Hall, Library Rwn, FNDC assets	Are there maintenance plans available? RFS shouldn't be required to alert need for cleaning gutters, mowing etc
Freese Park maintenance, upkeep	Mowing schedule? Also slippery and potentially unsafe approach to playground when wet. RFS's put in by community.
Non-notified vs Notified resource consents	Concern that some resource consents affect communities, and yet are non-notified. Need for clear guidelines for communities and discussion with FNDC, with regard to public interest on new consents.
Engagement with FNDC, understanding process.	People want to know the best way to get action on issues important to them: RFS's are the first point of call, CB members can support if this is not effective, however needs to be advice re which organisation are responsible for which service, where. There is also a need to ensure all areas in our rohe can engage in Council processes. Request for support from communities to develop Community Plans that can feed into the CB Strategic Plan, and the LTP.
Safety in Community	Concern in Rawne and Opononi-Omapere re safety in the community. Neighbourhood Support has begun in Omapere-Opononi, is being considered in Rawene. What else might be offered via FNDC?
Housing	What support can FNDC provide to organisations working on the local housing crisis?

Safe Cycling	Many roads are unsafe for cyclists, including Rawene Road, while increasing number of cyclists are coming to Hokianga via the Far North Cycleway, the BOI Hokianga Cycle Trail and Tour Aotearoa Brevet. The Pump Track Rawene needs support to make it usable.
Climate Change	What actions are FNDC doing to mitigate and adapt to the Climate Crisis with regard to our rohe?

Other Issues

Concrete bollards were placed at Russell Esplanade, Rawene, without discussion with RARA. Unattractive.

Fire hazards; long dry grass, pampas on roadsides, pine plantations and scrub after harvesting.
