Project Outline:

We believe there is a real community need for improved access to homegrown fresh healthy local fruit and vegetables in the Hokianga area. The Hokianga is disadvantaged by not having significant access to larger food stores like supermarkets or specific fruit and vegetable suppliers.

By establishing the growers market, community members will benefit from being able to attend and purchase a variety of produce.

Growers-to-Community connection points like this market will create economic opportunities for small to mid size home food growers, increase a broader consumer choice and enables direct regular access to healthy fresher food. It also benefits community members by being able to buy direct from the grower therefore eliminating an added third party mark up cost.

It may even inspire local groups to look at a business enterprise to establish a supply of regular kai for the market.

We have been granted FNDC permission to use Freese Park at the southern end of Omapere.

The Growers Market will operate on the 1st and 3rd Sunday of each month starting in November from 8am- 12pm.

Vendors will set up their stalls in the park, with fresh produce that they have either grown or made themselves.

We are not running the markets as a business venture at all, no profits are being made by the organisers, all profits/sales go directly to vendors and there is no fee for the stall holders to have a stall. All the organising hours will be done on a voluntary basis.

Both organisers Sandy-lee and Kara have an extensive work history in organising and coordinating community events, including ArtBeat Festival and the Night Markets in Whangarei and the Grey Lynn Park Festival in Auckland.
